

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that Scope 1 & 2 carbon emissions will decrease over the next eight years to **43** tCO_2e by 20**30**. This is a reduction of **40**%. Report of scope 3 carbon emissions is continuing to rise as we are adding more detail inline with the GHG annual reporting changes, adding such metrics as employee commuting, home working, freight, waste from buildings and cloud services consumed.

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 20**20** baseline. The carbon emission reduction achieved by these schemes equate to **26** tCO₂e, a **36**%ge reduction against the 20**20** baseline and the measures will be in effect when performing the contract

The adoption of LED/PIR lighting controls, movement of data centre to cloud services, changes to policy resulting in a reduction in company travel and flights and the electrification of the company fleet.

Axians has previously reported Scope 1 & 2 emissions in accordance with Streamlined Energy and Carbon Reporting (SECR) to our parent group VINCI Energies UK & I but from 2022 will pay particular attention to set a GHG Target and Tracking Emissions over Time.

In the future we hope to implement further measures such as:

Environmental management certification to ISO14001, further LED lighting controls, change in premises to remove gas consumption and following the NetPositive action plan especially in respect of supply chain management.

Axians will continue to follow the Corporate Value Chain (Scope 3) Standard and, in 2023 will pay particular focus to:

- Identify GHG "hot spots" and prioritize reduction efforts across the value chain
- Set scope 3 GHG reduction targets
- Quantify and report GHG performance over time

Declaration and Sign Off
